## INTERNATIONAL STANDARDS CERTIFICATION

#### Look for therapy chairs

that have CE mark and FDA registration and that they meet all the international standards (e.g. IEC 60601-1). In addition to CE Declaration of Conformity and FDA registration, consider chairs that comply with other relevant standards specific to your region or healthcare setting. Choosing chairs with multiple certifications demonstrates a commitment to meeting global safety and quality standards, ensuring confidence in the product's performance and regulatory compliance. Always verify the authenticity of certification documents provided by the manufacturer to guarantee the legitimacy of their claims.

## VERIFY MANUFACTURER'S COMPLIANCE

#### Ensure that the therapy

**chair** meets the strict regulations of the Medical Device Regulation (MDR). Compliance with MDR guarantees adherence to the highest standards of safety and performance, as mandated by the European Union. All MDR compliant medical device must have a UDI (unique device indentifiation) number. You may check it at EUDAMED by clicking on this link: <a href="https://ec.europa.eu/tools/">https://ec.europa.eu/tools/</a> eudamed. If a medical device has not got a UDI, it is not legal to market it in the EU. Additionally, verify if the manufacturer conducts regular audits and quality checks to maintain compliance with regulatory standards. It is essential to prioritise chairs from manufacturers with a proven track record of regulatory adherence and commitment to patient safety.

# CONTROL OF RESELLERS COMPLIANCE

Before buying, check the MDR compliance of the reseller submitting the offer. You can also do this by checking the EUDAMED database. Make sure that the reseller is a registered medical device distributor on the EUDAMED list. Ask about the reseller's quality management system and its procedures to ensure continued compliance with regulatory requirements. The reseller is your first point of contact for service requests or product-related problems and should be a long-term and reliable partner. By conducting thorough due diligence, you can minimize the risk of purchasing from a non-compliant reseller and maintain the highest standards of patient care at your facility.
